8 Planning.

- 8.1 3PL/2019/0677/F: Greenhouses Direct Limited, Roudham Road, Harling Road, Roudham. Application for Erection a detached store building and lean-to extension to existing factory/warehouse. It was noted that the Clerk has responded "no objections" using his delegated power, after consultation with four Members.
- 8.2 **3PL/2019/0720/F: St Georges Distillery, Harling Road, Roudham**. Retrospective application for staff and overflow car park. It was **resolved** that the Council had no objections.
- 8.3 **3PL/2019/0737/F: The Old School, Watton Road, Larling**. Application for Erection of two detached dwellings with associated parking and turning space. It was **resolved** that the Council objected on the grounds of poor access onto a bend in the B1111 (the access being shared with the old school for which a further application is awaited and the adjacent 3-bed dwelling), it extends ribbon-development in the village, the development is too dense cramming two over-large properties into the available space, and the black timber cladding and stone block is totally out of character with Larling. In addition, the development is adjacent to a land-mark building in the village which is going to be left undeveloped for the time being, which the Council regretted.

Vacancy. It was **agreed** that Mr Simon Armes be co-opted to the Council to fill the vacancy caused by there being an insufficient number of persons validly nominated at the 2 May election to fill the vacancies in respect of which the election was held. (*Representation of the People Act 1985, s. 21(1)(a))*

Mr Armes signed his Declaration of Acceptance of Office and joined the Meeting. He also completed a Disclosable Pecuniary Interests & Other Registrable Interests form.
