- 1 **Apologies for absence.** It was **resolved** to accept the reasons for the apologies for absence offered by Councillors Chapman and Nelstrop.
- 2 **Declarations of interest.** Councillor Gosling declared a Disclosable Pecuniary Interest in item 8.3.
- 3 **Dispensations.** None.
- 4 **Public participation session.** None
- 5 **Minutes.** The minutes of the meeting held on Thursday, 17 June 2016 were **confirmed** and **signed**.
- 6 **Matters arising.**
 - 6.1 [6.1] **Blocked gullies on B1111 south of level crossing.** Yet again Norfolk County Council Highways has done nothing about this problem, despite promises to look into the gullies. The Clerk will chase again. He was also asked to report that the grips on Church Hill needed clearing so as to lessen the amount of water which flows off the highway into residences at the start of Roudham Road, and also to report that a pump may not be working properly at the B1111/A11 underpass.
 - 6.2 [6.2] **ENF/44/16/PAR: Sandwich bar, Roudham Road Industrial Estate.** An Officer from Breckland Council's Food and Health & Safety team reports that a full food inspection was carried out three months ago. The business has registered as a food business, and received a 5 rating as there were no significant food hygiene issues. Concern was expressed that vehicles stopping at the sandwich bar were causing problems and danger to other users of the estate, and the Clerk was asked to contact District Councillor Ellen Jolly to see if she could get the Enforcement team to hurry up the submission of an application so that these problems could be exposed to wider scrutiny, and perhaps eliminated.
 - 6.3 [6.3, Minutes of 18 December 2014] **Roudham Village Sign.** Councillor Martin reported that she had cut the grass on the corner by the Village Sign, and would be doing more to tidy it up. The Chairman thanked her on behalf of the Council.
