- 1. Apologies for absence. No reasons for apologies were accepted.
- 2. Declarations of interest. None.

- 4. Public participation session. None.
- 5. **Minutes**. The minutes of the meeting held on Thursday, 18 November 2021, were confirmed and signed by the Chairman.
- 6. Matters arising.
 - 6.1. [8.1] Application 3PL/2021/1453/EU (Holbrook). As instructed, the Clerk contacted Michael Haslam, who responded saying that, "evidence from local people with personal knowledge of the site and who are prepared to say that it was not used for the purposes described in the application on the date claimed should be sufficient to cast real doubt on the facts that have been submitted in support of the application." The Clerk also challenged the planning Officer about the redaction of the bulk of the applicant's evidence (appendices A & B to the Planning Statement), and was told that this was necessary because of GDPR confidentiality. He has raised this with Cllr. William Nunn, and also advised NCC of the application. As a result of the latter, their officer visited, as there was concern that waste processing might be taking place. No waste processing equipment was found.
 - 6.2. [16, Minutes of 15 April 2021] **Covid and delegated powers**. The Prime Minister has now announced some reversion to Covid restriction measures, but the Government has still not done anything about making virtual meetings possible. The Clerk was asked to write to Liz Truss, MP, and also to Kemi Badenoch, Minister for Levelling Up Communities, urging them to implement emergency measures again to allow Councils to meet virtually for the safety of Councillors, staff and public
